- \* Camp will provide medical-accident insurance, all program supplies, two daily snacks, and admissions and transportation for all trips.
- \* I grant permission for my child/children to participate in all camp activities, including trips away from camp grounds (dates and destinations to be provided at a later date).
- \* All sessions with outside professionals (ie: OT / PT / tutoring, etc) must be coordinated by the professional with the camp office a minimum of one day before the services are to be provided. Camp will not be responsible for fees incurred from changes not coordinated with the camp office.
- **All Applications must include a non-refundable payment of \$400 per child.**

  - If payment is made via yisi.org, please provide payment confirmation email with application.
- **Early Bird Pricing- rates are \$1550 for YISI members and \$1650 for non-members For the Divisions K'tan tan Gimmel, Daled, Anaphim, MissMiddos, Masmidim \***
  - Initial deposit amount of \$400 PER CHILD must be received by **March 17, 2019.**
  - Second payment of \$350 PER CHILD must be received by **April 14, 2019**
  - Third payment of \$350 PER CHILD must be received by **May 19, 2019.**
  - Remaining balance of \$450/\$550 PER CHILD MUST be paid in full by **June 21, 2019.**
- \***Tweens** initial deposit of \$450. Three equal payments of \$500 for members. Deposit is \$500 for non-members
- \* **Ktan tan Aleph and Bet** final payment is \$350/\$450
- **For Enrollment after March 17, 2019, rates are \$1650 for YISI members and \$1750 for non-members.**
  - Deposit of \$400 PER CHILD (nonrefundable)

- \* I agree to the YISI Day Camp Refund Policy (not including initial \$400 deposit), as follows:
  - Should payments not be made by the above-mentioned dates, a Day Camp Committee representative will contact you. If payment is not made within two (2) days from that contact, your child's/children's spot(s) in the Day Camp will be forfeited. Refunds (except for initial \$400 deposit) will be granted with a \$150 administrative fee per camper.
  - Refunds requested in writing prior to 5/1/19 will be granted with a \$25 administrative fee per camper.
  - Refunds requested in writing between 5/1/19 and 5/31/19 will be granted with a \$225 administrative fee per camper.
  - After 6/1/19 camp tuition is non-refundable.
  - There is no reduction or refunds of fees due to absence, illness or withdrawal from camp.
  - Campers who leave early from one session are not entitled to make up those days in the following session.
- \* I agree that my children may be photographed, and their pictures may be used in future camp promotional materials, including, but not limited to the brochure and the YISI website.
