By signing this form, I agree to the following terms and conditions:

- **Camp will** provide all program supplies, two daily snacks and admissions and transportation for all trips.
 - I grant permission for my child/children to participate in all camp activities, including trips which take place off campus. (dates and destinations to be provided at a later date)
 - I agree to pay the Lice fee of \$10 for the summer. If your child is not present during any scheduled in-camp lice checks, your child cannot return to camp without a note from a reputable Lice checking company. (Lice checker must be pre-approved by YISI Day Camp)
 - All sessions with outside professionals (OT,PT etc.) must be coordinated by the professional with the camp office a minimum of one day before the services are to be provided. Camp will not be responsible for fees incurred from outside professionals for any reason.
 - I agree that my children may be photographed, and their pictures may be used in future camp promotional materials, including, but not limited to the brochure and the YISI website.
 - If the camper's conduct is deemed inappropriate or harmful to other YISI campers or staff members, the camper may be dismissed at the sole discretion of the Director with no refund nor reduction of fee.
 - In the event that YISI is forced to resort to legal means to collect any outstanding amount due, I agree that I am obligated to pay YISI's reasonable attorney's fees plus any cost of the court incurred by YISI in the collection or enforcement of the debt.
 - I agree to follow all YISI COVID protocols put in place by camp including protocol changes which may be implemented and put into effect throughout the summer as put forth by DOH.
 - I will adhere to any protocols that may change throughout the duration of the summer.
 - All parents are responsible for checking with camp for updated travel protocols before traveling. Parents are required to inform camp of any travel outside the tri-state area prior to the travel date. Campers must abide by DOH quarantine guidelines for travel. No refunds or credits will be issued for quarantine related to traveling.
 - There will be no quarantine refunds if your child/children bunk must quarantine.
 - There will be no refunds issued should your child be required to quarantine due to personally testing positive for COVID or by having direct exposure.
 - If camp protocols are not adhered to, YISI reserves the right to remove a child from camp with no refunds offered.
 - I agree that myself and my child/children will adhere fully and entirely to CDC and DOH guidelines regarding COVID including but not limited to mask wearing and quarantining.
- **Applications must include a non-refundable payment of \$400 per child.**

For all K'tan Division

- **Rates are \$1400 for YISI members and \$1500 for non-members**
 - Initial deposit amount of \$400 PER CHILD must be received by **March 21, 2021.**
 - Second payment of \$300 PER CHILD must be received by **April 18, 2021.**
 - Third payment of \$350 PER CHILD must be received by **May 16, 2021.**
 - Remaining balance of \$350/\$450 PER CHILD MUST be paid in full by **June 13, 2021.**

For Boys and Girl's Division (including trip and in-camp programming fee)

- **Rates are \$1525 for YISI members and \$1625 for non-members**
 - Initial deposit amount of \$400 PER CHILD must be received by **March 21, 2021.**
 - Second payment of \$350 PER CHILD must be received by **April 18, 2021.**
 - Third payment of \$375 PER CHILD must be received by **May 16, 2021.**
 - Remaining balance of \$400/\$500 PER CHILD MUST be paid in full by **June 13, 2021.**

- FOR THOSE CHILDREN OPTING IN FOR OUR HOT LUNCH PROGRAM, PAYMENT OF \$300 MUST BE MADE BY **JUNE 21, 2021.**

* I agree to the YISI Day Camp Refund Policy (not including initial \$400 deposit), as follows:

- Should payments not be made by the above-mentioned dates, a Day Camp Committee representative will contact you. If payment is not made within two (2) days from that contact, your child's/children's spot(s) in the Day Camp will be forfeited.)
 - Refunds requested in writing prior to 5/1/21 will be granted with a \$125 administrative fee per camper.
 - Refunds requested in writing between 5/1/21 and 5/31/21 will be granted with a \$225 administrative fee per camper.
 - After 6/1/21 camp tuition is non-refundable.
 - There is no reduction or refunds of fees due to absence, illness or withdrawal from camp.
